ORDER

Sri V. Narayana Murthy, MLA., Alampur has represented to Govt. for starting a Govt. Degree College at Mandapeta, East Godavari District. He has produced the receipts of deposits in the Treasury at Alampur amounting to Rs. 10.00 lakhs (Rs. 5.00 lakhs towards Corpus Fund and Rs. 5.00 lakhs towards construction of buildings and provision of Labarequipment). His request has been examined in consultation with the Director of Higher Education who has submitted proposals in the matter.

2. Government after careful consideration of the proposals of the Director of Higher Education sanction upgradation of the Govt. Junior College, Mandapeta, East Godavari District into a Govt. Degree College during the year 1989-90 subject to the following conditions:-

1. The new Degree College should function as a separate entity.
2. There should be separate teaching staff and the staff of the Junior College would not be assigned any teaching work in the Degree College classes.
3. The ministerial staff of Junior College will also attend to the Degree College.

3. The Upgradation into Degree College sanctioned above, is also subject to the following conditions in addition to those down in G.O. No. 29 Education, dated 5-2-1987.

"Donation of Rs. 10.00 acres of land for construction of buildings etc. shall be given immediately. The remaining 5.00 acres shall be provided by the Educational Agency within one year as laid down in G.O.Ms.No. 29 Education, dated 5-2-1987"

The College will have B.A., B.Com. & B.Sc. (Computer Science). The medium of instruction shall be Telugu. English medium classes can also be opened provided there is a minimum strength of 30 students in the course concerned and with the prior permission of the Govt. The Director of Higher Education should obtain affiliation to this college from the Andhra University immediately.

Non-teaching Staff

The non-teaching staff of the Govt. Junior College, Mandapeta will continue to do work of Govt. Degree College, Mandapeta also as mentioned above.

5. The above posts shall carry the usual scales of pay and allowances admissible as per rule in force from time to time.
6. For the present, the Govt. Degree College, Mandapeta shall be located in the premises of Govt. Junior College, Mandapeta.
7. Sanction is also accorded for incurring an expenditure of Rs 1,82,600/- (Rupees one lakh eighty two thousand six hundred only) towards non-recurring expenditure as detailed below:-

8. The total expenditure sanctioned towards recurring and non-recurring expenditure as in para 4, 5 and 7 above shall be limited to Rs 4.626 lakhs as shown below:-

9. The above amount of Rs 4,62,600/- (Rupees four lakhs sixty two thousand and six hundred only) shall be met within the current year's Budget provision by way of reappropriation from the following Head of Account:-

"2202-General Education - 03 University and Higher Education - MH.103 - Govt. Colleges and Institutions schemes included in Plan - SH (05) Govt. Junior Colleges for Girls - 010 - Salaries (Plan)".

and shall be added to the following list of accounts:-

"2002 Govt. College - 03 - Only City and Higher Education - 141, 103 - Govt. College and Institute - Services included in the Plan 141 (67) Govt. Degree College - 101 Plan - 010 Salaries - 040 - Office expenses - 041 - Other expenses - 150 - Machinery and Equipment (Plan)".

10. The Principal of the Government Degree College at Mandapeta is permitted to incur the expenditure of Rs 1,82,600/- (Rupees one lakh eighty two thousand and six hundred only) sanctioned in para 6 above towards contingencies (i.e., purchase of furniture, Library Books, Contingencies and Physical Education Material) during 1989-90 as per the procedure laid down for the purchase of various items.

11. This order issues with the concurrence of Finance and Planning (EE) Department, vide their U.O.No.1430/EE/89, dated 3.2.1989.
