1. Parties

2. OBJECTIVES OF THE MOU:

The objectives of this Memorandum of Understanding are:

- ✚ To provide a formal basis for initiating interaction between the institutions mentioned above.
- ✚ To explore the mutual interest and promote exchanging of expertise of the faculty of both Parties.

3. TERMS OF MOU

- ✚ This MOU is effective upon the day and date signed and will be executed by the parties from September, 2022 and shall remain in full force and effect for not longer than 5 years from 2021-22 to 2025-26. This MOU may be terminated, without cause, by either party upon two months written notice, which shall be delivered by hand or by certified mail to the address listed above.

4. Responsibilities of Parties

- ✚ The faculty and students of Party – I will teach/train the faculty and students of Party – II, so as to enrich the teaching experience of faculty and learning experience of students of the Party – II by means of Guest Lectures, Workshops (during regular working days) as per the schedule resolved in the meeting held on 22-08-2022 in the Chamber of the Principal, Government Degree College, Mandapeta.
- ✚ The Party – II may request some of the faculty or students of Party – I to address the faculty or students of Party – II.
- ✚ Mere participation of faculty and students of Party – I in teaching the faculty and students of Party – II according to this MOU does not carry any right or any legal entitlement to demand for placement with Party – II.
- ✚ This MOU has been made for staff and students without any financial commitment on the part of both the colleges.
- ✚ The Colleges shall entrust a faculty member in their respective colleges to liaison between the parties.
- ✚ Any other appropriate module to enhance knowledge and skills.
