1. Parties

- The Party – I may request some of the faculty of Party – II to address the faculty or students of Party – I.
- This MoU does not carry any right or any legal entitlement to demand for placement with Party – II.
- This MoU has been made for staff and students without any financial commitment on the part of both the organizations.
- Any other appropriate module to enhance knowledge and skills.
